PUBLICATION OF A TRANSPARENCY NOTIFICATION

On 1 July 2025, Care Property Invest has received a transparency notification.

As a result of a disposal of voting securities or voting rights, the overall percentage of voting rights exercisable by BlackRock, Inc. decreased on 30 June 2025, but remained above the 3% threshold.

In accordance with Article 18 §1^o Article 6 §3 of the Law of 2 May 2007 on the disclosure of major shareholdings in issuers whose shares are admitted to trading on a regulated market and containing various provisions, a notification to the issuer and the FSMA is required.

This transparency notification dated 1 July 2025 contains the following information:

- **Reason for the notification:** Decrease in the overall percentage of exercisable voting rights, but remained above the 3% threshold as a result of the disposal of voting securities or voting rights.
- **Notification by:** A parent undertaking or a controlling person.

Care Property Invest purchases, builds and renovates high-quality healthcare real estate (residential care centres, groups of assisted living apartments, residential complexes for people with a disability, etc.), fully tailored to the needs of the end user and then makes it available to solid healthcare operators on the basis of a long-term contract.

The Company is developing an international portfolio of healthcare projects, which currently counts 151 projects, spread across Belgium, The Netherlands, Spain and Ireland.

The market capitalisation of Care Property Invest amounted to approximately €462 million on 01/07/2025. The Company aims to create a stable share for its shareholders with a low risk profile and a stable and steadily growing dividend.
