In accordance with Article 15 of the Law of 2 May 2007 on the disclosure of major shareholdings, Care Property Invest NV ("**CP Invest**" or the "**Company**") announces the following information following the completion of a capital increase and the issuance of new shares on 15 December 2025:

- The Company's capital amounts to EUR 251,502,928.06 after the capital increase.
- The total number of voting securities amounts to 42,272,952 after the issuance of new shares (all shares).
- The total number of voting rights therefore amounts to 42,272,952 after the issuance of the new shares (all attached to shares). This number is the denominator for notifications under the transparency regulations (i.e., notifications in case of reaching, exceeding or falling below statutory or legal thresholds). In addition to the legal thresholds, Article 15 of the Company's Articles of Association provides for an additional statutory threshold of 3%.

The new shares are admitted to trading on the regulated market of Euronext Brussels and have the same ISIN code as the existing shares (BE0974273055). This information, as well as the shareholder structure, is available on the Company's website (www.carepropertyinvest.be).

The market capitalisation of Care Property Invest amounted to approximately €414 million on 12 December 2025. The Company aims to create a stable share for its shareholders with a low risk profile and a stable and steadily growing dividend.
