Care Property Invest announces the withdrawal of the special character and listing of 150,000 shares in accordance with Article 15 of the Transparency Act.

Care Property Invest held an extraordinary shareholders' meeting on 16 May 2018 with the objective, among others, of withdrawing the rights and benefits granted to the 150,000 special shares.

As a result of the decision of the extraordinary general meeting, the rights and benefits granted to the 150,000 special shares are withdrawn and the special shares are converted into ordinary shares. As a result of this conversion, the Company's share capital is no longer represented by 19,172,845 ordinary shares and 150,000 special shares, but by 19,322,845 ordinary shares. Each of these shares confers one vote at the General Meeting and therefore represent the (unchanged) denominator for the purposes of transparency notifications (i.e. notifications in the event of reaching, exceeding or undershooting the statutory or legal thresholds). In addition to the legal thresholds, Article 15 of the Company's articles of association provides for an additional statutory threshold of 3%.

The former 150,000 special shares in the Company, have been admitted to trading on the regulated market of Euronext Brussels as of 27June 2018 and have the same ISIN code as the existing shares in Care Property Invest (BE0974273055).
