Care Property Invest acquires a residential care centre in New Dunsink (IE)

Schoten, Belgium – Monday 6 June 2022

To further develop its strategic growth plan in Ireland, Care Property Invest last Friday acquired the project 'Elm Green Nursing Home', located in New Dunsink, County Dublin, a residential care centre with 120 residential places (all of which registered with HIQA - Health Information and Quality Authority) and 27 assisted living apartments. The total conventional value of the project amounts to approximately €26.7 million.

The transaction took place in the form of an asset deal whereby Care Property Invest acquired the real estate of this project through its Irish subsidiary, Care Property Invest Emerald Ltd.

The project is operated by DomusVi, one of the largest international players in the field of (residential) care for the elderly, on the basis of a new long-term leasehold agreement of the 'triple net' type with a minimum duration of 15 years (renewable and annually indexable). The project generates additional income for the Company as of today.
