
Care Property Invest announces the completion of the 'Margaritha Maria Kerk' in Tilburg (The Netherlands), which has been redeveloped into a care residence.

Schoten, Belgium - Thursday 15 July 2021

Yesterday Care Property Invest completed the 25 care apartments located in the church building of the redevelopment project 'Margaritha Maria Kerk' in Tilburg (province of North Brabant), further expanding its operative real estate portfolio in The Netherlands. The completion of the 7 remaining care apartments in the adjacent vicarage is expected in the second half of 2021. This monumental church was converted by developer Verdouw Advies B.V. on behalf of the Company into a modern care residence with 25 residential units, representing a total investment of approximately €7.7 million. As of today, the church building will be taken into use by Senior Living B.V., a subsidiary of healthcare operator Korian Nederland, which entered into a 'triple net' long-term lease agreement with a minimum duration of 20 years with Care Property Invest. The Dutch property portfolio now comprises 19 projects, 10 of which are operational.

'The transformation of the Maria Margaritha Kerk is a strong example of how Care Property Invest is injecting new life into existing buildings by converting them for other uses. It became a balancing act between preserving the most valuable elements of this church and creating a comfortable, but also very unique living environment for its residents. This project also strengthens our cooperation with established healthcare operator Korian Nederland.'

Both buildings were transformed into modern senior citizen complexes with a unique character thanks to the authentic elements that were preserved in this national monument.		
Location:	The project is located in a pleasant residential area, centrally located in the municipality of Tilburg, on the triangle of the Zorgvlied, Rooi Harten and Korvel districts. 'Kromhoutpark', a pharmacy and several supermarkets, are located close to the project.		
Year of construction/ renovation:	The church has been completed on 14 July 2021 and the completion of the vicarage is expected in the second half of 2021.		
Transaction:	Asset deal: Acquisition through its Dutch subsidiary, Care Property Invest.NL3 B.V.		
Type of contract:	New long-term leasehold agreement of the 'triple net' type with a duration of at least 20 years (renewable and annually indexable). The 25 residential units within the church structure will generate additional income for the Company as of today.
